SKATING UNDER THE STARS

Terms and Conditions

1. This ticket admits only one person into Skating Under the Stars (SUS) and is only valid for the date and session specified. The duration of each session is 30 minutes.
2. No admission for children below 4 years old. Children under 0.9 metres must be accompanied by a supervising adult aged 18 years and above on the skating rink at all times – both of whom must hold a valid SUS admission ticket.
3. Admission ticket into Christmas Wonderland is ticketed separately and can be purchased online or onsite, subject to availability.
4. All tickets are strictly non-exchangeable, non-transferable and non-refundable, and shall not be resold, redistributed or remarketed without the prior written consent of Blue Sky Events Pte Ltd (BSEPL).
5. Tickets obtained from any unauthorised ticket reseller shall be deemed invalid and BSEPL reserves the right to cancel any ticket that has been resold and deny entry to any such ticket holder.
6. Lost tickets will not be reissued.
7. BSEPL reserves the right to close SUS for private booking(s) without any prior notice.
8. No re-admission into SUS is allowed upon leaving the skating rink.
9. This ticket includes rental of one pair of skates and must be worn with socks at all times. Socks can be purchased at the ticketing booth. For safety reasons, only Ticket Holders wearing skates are allowed onto the skating rink.
10. Ticket holders acknowledge that skating is an activity which possesses elements of risk, hazards and dangers, and hereby release, waive and discharge BSEPL from all liability and assume full responsibility of any risk of bodily injury, death and/or disability inherent in viewing and/or participating in SUS.
11. Parent/Guardian of children under 12 years of age entering the skating rink are required to sign an indemnity form.
12. Ticket Holders are discouraged from using electronic devices in the skating rink. BSEPL will not be liable for any loss and/or damage to your devices.
13. Skating aids are available on a first come first served basis. Priority will be given to children.
14. Photography, audio and video recording and streaming for commercial purposes are strictly prohibited. BSEPL may take photographs or recordings of attendees at the Event and attendees hereby consent to the use of his/her image or recording for any marketing or publicity purposes.
15. This is an all-weather event. BSEPL may at any time, with or without prior notice, cancel, reschedule, suspend, change or vary any part of SUS including its Schedule and Terms and Conditions of ticket sales for any cause beyond its reasonable control and without recourse.
16. BSEPL reserves the right to refuse entry or evict any person for violent, disruptive, abusive or inappropriate behavior, or if there is non-compliance with any of these Terms and Conditions.
